- B. Covered under clause (i) of Schedule VII to the Companies Act, 2013 Eradicating extreme hunger, poverty and malnutrition, promoting preventive health care, sanitation and making available safe drinking water

C. Promoting Education:

Covered under clause (ii) of Schedule VII to the Companies Act, 2013 – Promoting education, including special education and employment enhancing vocational skills especially among children, women, elderly and differently abled and livlihood enhancement projects; monetary contributions to academic educational institutions with the objective of assisting students in their studies.

D. Empowerment of Girl Child:

Covered under clause (iii) of Schedule VII to the Companies Act, 2013 – Promoting gender equality and empowering women; setting up homes, hostels and day care centres for women and orphans; setting up old age homes and such other facilities for senior citizens and adopting measures for reducing inequalities faced by socially and economically backward groups

E. Clean Environment – Reduce Carbon Foot Print:

Covered under clause (iv) of Schedule VII to the Companies Act, 2013 – "ensuring environmental sustainability, ecological balance, protection of flora and fauna, animal welfare, agroforestry, conservation of natural resources and maintaining quality of soil, air and water".

TFL Quinn India will undertake CSR activities either directly or through various implementing agencies identified from time to time as approved by the CSR Committee. The CSR Committee will also decide on the location of CSR activities.
